**Re: Transparency and Accountability in General Election 2020**

Dear Mr. Field:

Thank you for responding to our prior letter. We appreciate your willingness to communicate on this important issue.

As a preliminary matter, you suggest a tour of the satellite election offices. Representatives from the Trump Campaign will gladly take your offer up at a later date. In the interim, however, we would like to address more pressing matters, like the variety of different answers the City Commissioners and their staff gave when we tried to enter these satellite **election** offices.

So, the question remains: Because no one disputes that voters cast ballots at these satellite election offices, are these polling places? If the answer is yes, then, as I outlined in my previous correspondence, we would like to immediately obtain credentials for our watchers under 23 P.S. § 2687 so that our qualified registered electors can observe the voting.

Your letter appears to indicate that your office does not consider these satellite **election** offices, where voting occurs, to be polling places. If that is the case, and these are "City offices" as you state, we would like the opportunity for representatives of the Trump Campaign to observe the ongoing process and business occurring in public areas of these sites. Based on what we saw yesterday, the Commissioners thoughtfully chose large spaces inside schools with plenty of space, ideal for social distancing, for these satellite offices. We, of course, join you in your concern for the health of residents. Accordingly, we are willing to have our temperatures taken, wear face masks and gloves, and socially distance from voters. We are ready, willing, and able to accommodate the demands created by COVID-19

because a transparent election is that important. And that is all we are asking for, election transparency guaranteed by the simple opportunity to watch.

The Campaign representatives will take all appropriate precautions as recommended by the CDC. We simply ask that we be permitted inside these public spaces where we can peacefully observe, as is our right. I note that the City Commissioners' Sunshine meeting took place today in a large space where everyone made sure to stay at least six feet from each other but could still observe the process. We ask for similar accommodations at these satellite election offices, especially as these chosen locations can certainly provide sufficient opportunity for everyone to spread out.

We ask that you respond no later than tomorrow, October 1, 2020 by 3:00 p.m. Protecting the integrity of the voting process necessitates immediate action and without a satisfactory resolution, the Campaign will move forward with its plan to seek court intervention.
