## From Fragmented Fields to a Unity of Effort for Early Childhood Development:

The SDGs and multisectoral ECD monitoring and evaluation systems

Healthy early childhood development (ECD) is key to a more positive future, as recognized through the inclusion of dedicated targets and indicators in the Sustainable Development Goals (SDGs) aimed at measuring progress among young children and their families.

The recent proliferation of new tools and indicators to measure ECD has prompted the need to take stock and unpack the measurement landscape to effectively inform the development or strengthening of multisectoral ECD monitoring, evaluation and reporting systems. Now is the time to unite the fragmented sectors that make up the field of ECD to support the establishment of comprehensive national multisectoral data systems for policies and programmes that will, in turn, improve the status of children and families.

## Goal

Inform and support data specialists and ECD leaders to identify their needs and build capacity to plan the development of national multisectoral ECD monitoring, evaluation, reporting, and policy and programme planning systems that consider and use SDG, regional and national indicators. In addition, to promote the identification of opportunities to establish regional networks to support countries and help them share experiences and lessons learned.

## **Objectives**

 Build interest in, and commitment to, establishing and strengthening national multisectoral ECD monitoring, evaluation and reporting systems

- Explain key processes and elements of national multisectoral ECD monitoring, evaluation and reporting systems
- Take stock of and unpack the ECD measurement landscape
- Encourage countries to improve the quality of monitoring and evaluation (M&E) instruments, integrated databases, and data use to help achieve SDGs related to ECD, inform regional and country target setting, and, ultimately, improve ECD programmes
- Highlight the importance of linking and utilizing data to inform programmes
- Identify regions and countries interested in receiving more in-depth training workshops and/or technical assistance to establish or improve their existing national multisectoral ECD monitoring, evaluation and reporting systems.

## **Audience**

The webinar series is targeted at the country and regional level, to a primary audience of data specialists, ECD policy planners, and practitioners working on M&E, programme evaluation, and policy development and implementation at the national level in the field of ECD. It is anticipated that UN and other international agencies (particularly those working at the regional and country level on ECD programming and M&E) and members of ECD regional networks will also find the webinar series informative and useful.
